Drafting is not formatting.

Today, technology can give you any format in seconds, but a format cannot think for you. Drafting is an art that begins with clarity: What do you want the court to ultimately grant you?

A good drafter knows which facts help the case, which harm it, what to highlight, and what to control. Without this clarity, no format can save the case.

Litigation is strategy, not guesswork. Many cases are won or lost on the drafting table, long before arguments begin.

This course does not give you more formats.

It teaches you how to think before you draft, the way drafting is actually practiced in courts.
